Narrative & Statements

Narrative - Qualls, Jeremy Dean - 2/1/2010 (Initial)

On this date I was dispatched to [REDACTED] Allen Chapel Rd. Deputy Brian Luetschwager, Deputy Bret Ward, Deputy Michael Thatch and I responded. We arrived. We was met outside by a white male subject, later identified as Mr. Nicholas Snider. Mr. Snider was intoxicated. He was having a hard time standing and speaking. While I was speaking to him I had to grab hold of him to keep him from falling. I asked him what was going on. He stated: I am a very famous model, you need to talk to her (Dianna Caster) she has been giving her kids beer. I asked him if he had any ID. He gave me his Passport. I contacted Dispatch. They could not find anything on him in ACIC. I asked him where he was from. He first told me Florida, He then changed and told me New York City. Deputy Ward spoke to Mr. Snider, while I spoke to Deanna Caster, she stated: Nicholas is a friend of hers from New York. He came to see her. She went to the Air Port and picked him up. They returned to her residence. He had been here for several days, when they got in to a verbal fight and she made him leave. He came back tonight and was intoxicated. He was yelling at her, telling her to hit him. He would not leave. She asked him several times to leave, he refused. Deputy Luetschwager placed Mr. Snider in hand cuffs and transported him to the Independence Jail where he was booked for public Intoxication and Disorderly Conduct. Court date of February 3, 2010 Mr. Snider was placed in the drunk tank. He was yelling: Let me out of her and hitting the window.

Narrative - Luetschwager, Gregory Brian - 2/1/2010 (Initial)

On February 1, 2009, at approx. 1:45 am, I Deputy Brian Luetschwager responded as back up for a call of a disturbance at [REDACTED] Allen Chpl. Rd. When I arrived I found the suspect, identified as a Mr. Nicholas Snider, outside speaking to Deputy Jeremy Qualls. Once Deputy Qualls spoke with the victims, he informed me that he would have charges on Mr. Snider and asked if I would transport him to Jail so he could get a statement from the complainant. At that time I placed Mr. Snider under arrest and placed him in my car for transport. While talking to Mr. Snider I could smell a strong odor of intoxicants about Mr. Snider person. Also while taking Mr. Snider to my car I had to keep him from falling several times due to Mr. Snider being intoxicated. While in transport to the County Jail, Mr. Snider kept trying to get me to stop the car and let him go. Mr. Snider stated to me, "If you stop I'll suck you dick and balls, if you let me go." Mr. Snider stated statements like this repeatedly, all the way to Jail. Once at the Jail, Mr. Snider also harassed the booking Jailer with similar sexual comments. Once Mr. Snider was placed in the drunk tank, he began banging on the window, and was still banging on the window when I left the Jail. I charged Mr. Snider with Attempting to Influence a Public Servant.
